PROGRAM STRUCTURE

Duration

- You will be placed into a home department, either Asset Management or Strategic Assets, from the outset.
- You will undertake a rotational program for 12 months and return to your home department.

Rotations

The rotations take place among the following areas:

- 7 months in the home function where the Analyst will be permanently placed, either Asset Management or Strategic Assets
- 3 months in the other department - Asset Management or Strategic Assets
- 2 months in the support functions (Legal, Risk, Finance etc.)

Training

Training for CFA (Chartered Financial Analyst) Level 1 will be mostly provided during the weekends or evening time to guarantee you can dedicate enough time to your on-the-job learning experience. Various additional programs are tailored to your personal development areas and cover technical topics as well as leadership skills. These will be provided through classes, online training, in-house workshops, external seminars, conferences etc.

Progression

You will be evaluated on a regular basis and you will receive feedback for further development. Candidates who perform well and achieve CFA Level 1 during the programme will be considered for promotion to Investment Associate.
